Position paper on flooding: In 2005, the European Land and Soil Alliance already released a comprehensive position paper in which they called for increased soil protection to prevent flooding. The paper has not lost any relevance to this day.

Sponge City Guide for Municipalities and Planners: Climate-adapted planning and building are becoming increasingly important to ensure safe and liveable housing in the future. This guide by the Bavarian State Ministry for the Environment and Consumer Protection contains proposed solutions on how a bluegreen infrastructure can be implemented in settlement areas.

Berlin Rainwater Agency: The agency wants to activate, animate and motivate citizens, urban planners and developers, city administrations as well as companies and housing associations to create an interactive network with focus on making cities more 'rain-proof' and climate-adapted.

Flood and flash flood prevention: The Bundesverband Boden e.V. (German Federal Soil Association) is calling for more preemptive soil protection to prevent floods and flash floods.

Rain Gardens: Private gardens can also be included in the conversion to a sponge city. For example, a campaign was launched in the greater Seattle area to create 12,000 'Rain Gardens'.

EU Mission Soil Health and Food: With a total of five planned missions, this one is intended to raise awareness of the importance of soils. The results will have an impact on the success of the European Green Deal and its quest for progress on climate, biodiversity and sustainable food.

Soil Care Network: The network is a global community of scientists, researchers as well as members of civil society with diverse backgrounds. It is intended to be a place where soil scientists and people interested in soil research can meet and exchange constructive and creative ideas.

SOILGUARD: The project is striving to create a future in which soil biodiversity conservation as well as ecological, economic and social well-being can be assured. A key challenge is to fill existing knowledge gaps regarding biodiversity and the ecosystem services provided by soil.

Climate-friendly agriculture: The New York State Senate passed the Soil Health and Climate Resiliency Act. The goal is to reduce the impact of agricultural practices on climate change through greater adaptation and soil conservation.

Joint Associations Paper 'Restarting Transport Planning': Various environmental associations joined forces to issue a paper demanding action from the German government: an immediate moratorium on new construction and expansion of motorways and adoption of a federal mobility law at the beginning of the next legislative period.

Farming for 1.5°: A new report entitled 'Farming for 1.5' endeavours to help Scotland achieve net-zero agriculture by 2045. The purpose of the study was to identify a consensus on the best way for Scottish agriculture to cap global warming to 1.5 °C.

Soil Protection Report: The German Federal Cabinet has approved the 5th Soil Protection Report of the Federal Government. The report reflects developments in the period from 2017 to 2021 at federal and state level as well as in the European and international domains.

German Federal Council adopts the 'Mantelverordnung' Ordinance: For the first time, the 'Mantelverordnung' (ordinance regulating ground water, substitute building materials, landfill and soil protection) is applied to the use of mineral waste such as construction rubble, slag or railway ballast throughout Germany. In order to protect soil and nature, the ordinance establishes uniform rules for backfilling of surface excavations, such as former gravel and sand pits.

German Peatland Protection Strategy. The German Federal Ministry for the Environment has published a National Peatland Protection Strategy for the first time. It contains the principles, goals and measures needed for successful peatland protection at the federal level.

Soil improvement – Looking for supporters

Soil4Life is looking for supporters: The Soil4Life Manifesto was originally established in 2019 and calls for better treatment of soils. It is a call to action for global and local decision makers. Stakeholders are currently petitioning for people to sign the manifesto. The Manifesto will be presented to UNESCO, FAO and the EU in 2022.

Climate Alliance members adopt forward-looking charter: Climate Alliance members adopted the new charter of the city network at the annual General Assembly on 8 September, renewing their commitment to ambitious climate protection measures at the local level. The charter outlines what equitable climate protection can look like locally. It also provides a target range to assist municipalities in their efforts for more ambitious emission reduction targets in the future. The charter emphasises the importance of figuring out how to combat global warming. From climate neutrality and 100% renewable energy to the introduction of a carbon price – the network uses the charter to provide its members with specific recommendations on how to drive sustainable and equitable transformation at their respective locations.
