On 17 November 2021, the EU Commission presented its new Soil Protection Strategy. It draws attention to the fact that soil is a limited resource and cannot be replenished! For a long time, efforts to create a uniform legal framework throughout Europe had failed due to the resistance of some member states. The adoption of the Soil Strategy raises new hopes. In Germany, too, something is happening. Soil protection has made it into the coalition agreement of the new government and is explicitly mentioned there.

Let's hope that 2022 can build on these positive initiatives and that European soil protection takes a decisive step in the right direction.

European Soil Protection Strategy: The EU Commission has presented a new EU Soil Strategy. The strategy provides a framework with specific measures for the protection, restoration and sustainable use of soils and proposes a number of voluntary as well as legally binding measures.

ELSA Annual Statement on the EU Soil Strategy: ELSA strongly welcomes the adoption of the EU Soil Strategy and has dedicated its Annual Statement to the issue. It stresses the importance of a legally binding regime for soil protection being widely discussed, developed and adopted.

DNR on the EU Soil Strategy: The environmental umbrella organisation Deutscher Naturschutzring (DNR German League for Nature Conservation and Environmental Protection) also welcomes the EU Commission's Soil Strategy and calls for action. Central to this is the development of a long overdue European legal framework in the form of a "Soil Health Law"

Soil protection in the Coalition Agreement: The Coalition Agreement of the future German government explicitly mentions soil protection on pages 41/42. Among other things, it announces that it will work at the European level for improved soil protection and binding regulations.

Reform of EU agricultural policy: The European Parliament has given the green light for the reformed Common Agricultural Policy of the EU. In future, it is to become more environmentally friendly, fairer, more flexible and more transparent. Among other things, 25% of direct payments must be used for environmental and climate protection measures in future.

Alliance against trade in humus certificates: CO2 emission certificates are not a suitable instrument for maintaining and building humus. More than 30 organisations and individuals from environmental and climate protection, agriculture and science have spoken out against the issuing of CO2 emission certificates as an instrument for maintaining and building up humus. The Soil & Land Alliance is one of the signatories.

Soil of the Year 2022: On the occasion of the International Soil Day on 5 December, Pelosol was singled out as "Soil of the Year 2022". The name is derived from the Greek (pelos = soft clay, mud) and expresses the high clay content of this soil.

Saving land: Saving land: With this project, CIPRA is campaigning for a turnaround in the use of land in peri-urban areas in order to transfer scientific findings into practice, make pilot examples visible and encourage imitation.

Environmental Prize: This year, biodiversity researcher Prof. Dr Katrin Böhning-Gaese, Director of the Senckenberg Biodiversity and Climate Research Centre, and peatland conservationist Prof. Dr h.c. Hans Joosten share the prize. Hans Joosten, who worked at the Institute of Botany and Landscape Ecology at the University of Greifswald until his retirement, received the environmental prize awarded by the Deutsche Bundesstiftung Umwelt (German Federal Environment Foundation).

News from the Climate Alliance

The time for action was yesterday — Climate Alliance at COP26 in Glasgow: Expectations before the climate conference were extremely high — perhaps too high. Given the different needs, resources and interests of almost 200 negotiating countries, the UN climate process is extremely complex. Real action will follow only after the agreements have been successfully ratified by national parliaments and transposed into national law. Despite all the shortcomings, each country committed to further action in Glasgow — potentially making an important contribution to avoiding failure at the international level. When it comes to action on the ground, the local level continues to have a hugely important role to play. Climate Alliance was on the ground in Glasgow making the voices of its members heard.
